The Laurence N. Nickey, MD, Lifetime Achievement Award

The award is not intended to be bestowed on a regular basis, but rather is intended to be a recognition bestowed only occasionally and then only upon a truly exceptional TMA physician who has made significant lifetime contributions to public health. This is an open call for nominations, and a bestowment is not guaranteed. Only Texas county medical societies (CMS) and TMA councils may submit nominations but are not obligated to do so. Each CMS or council may nominate no more than one individual for receipt of the award, by submitting the following nomination form in its entirety.

ORIGIN AND PURPOSE OF THE AWARD

The award commemorates Laurance N. Nickey, MD (1931-2018), a pediatrician and longtime director of the El Paso City-County Health District. Dr. Nickey was a dedicated border health advocate who frequently reminded the public "diseases have no passports." To learn more about Dr. Nickey's contributions to public health in Texas, please read the El Paso Times' (2018) reviews of his life and work.

INSTRUCTIONS

The Texas Medical Association's Council on Science and Public Health is pleased to accept nominations from county medical societies and TMA councils until October 31, 2023. Incomplete or late nominations will not be considered. In the event a

nominee is selected to receive the award, the award will be presented at a formal awards ceremony held during the TMA Leadership Summit in January 2024.

You may exit and return to the nomination form at any time. Your progress will be saved as long as you use the same computer and link each time.

The scored portion of the nomination contains 10 required short answer questions with a limit of 1000 characters per question. Narrative or list form is acceptable. You may find it easier to compose your responses in a Word document and paste them into the nomination form. If you prefer this method, the short answer questions begin on Page 4 of the form.

ELIGIBILITY CRITERIA

Only nominees meeting the following criteria will be considered:

- Texas Medical Association member physician
- Demonstrated professional focus on public health
- Nominated by a county medical society or a TMA council. Each county medical society and TMA council may only nominate one person.
- At least 10 years of medical practice

SCORING

Eligible nominees will be evaluated on the following:

- Public Health Progress and Achievements (20 points)
- Commitment to Community (15 points)
- Mentoring (5 points)
- Leadership (5 points)
- Impact Across Geographies and Jurisdictions (5 points)

Category I. Public Health Progress and Achievements (20 points)

How Dr. Nickey exemplified this category:

While practicing pediatrics in El Paso, Dr. Nickey became engaged in maternal and child health, public health, and infectious disease issues. In the 1960s, he organized the Oral Polio Immunization program, which vaccinated hundreds of thousands of people in southwest Texas and New Mexico in 1963-1965, while also working strategically for years with the U.S. Public Health Service to organize a tuberculosis control unit to serve the El Paso area. As long-time director of the El Paso City-County Health District, Dr. Nickey was instrumental in increasing access to prenatal care with implementation of the Improved Pregnancy Outcomes program, resulting in a decrease in the proportion of El Paso women with no prenatal care from 40% to 11%.

Dr. Nickey's received many awards for his public health achievements, including:

- Distinguished Service Award for securing legislation for newborn health insurance in the State of Texas, Texas Pediatric Society, 1973
- Conquistador Award (highest award offered by the City of El Paso) for Outstanding Contribution to the Public's Health, City of El Paso, 1989
- Conquistador Award for Contributions to Public Health in El Paso and Binationally, City of El Paso, 1995
- Nathan Davis Award for Outstanding Efforts to Promote public Health as a Local Health Officer, American Medical Association, 1995
- S.T. Turner Award for Outstanding Career of Service and Contributions to the Practice of Medicine and the People of El Paso, Texas, El Paso County Medical Society, 1996
- James E. Peavy Memorial Award for Distinguished Contributions to Public Health in Texas, Texas Public Health Association, 2001
- The Dr. Charles W. Daeschner Lifetime Achievement Award, Texas Pediatric Society, 2002

In 1995, Dr. Nickey retired from his formal role in public health, but his volunteer service continued with TMA, where he served as a member of TMA's Council on Public Health, with a focus on TMA's efforts on border health issues. Dr. Nickey was also active in the El Paso County Medical Society and several other public health and medical entities in El Paso.

- Vice President, Texas Perinatal Association, 1976-1977 (Charter Member)

- President, United States-Mexico Border Health Association, 1991-1992
- Member and consultant in multiple TMA councils and committees, 1970s-1990s

How Dr. Nickey exemplified this category:

In addition to his volunteer work, Dr. Nickey served as a mentor and inspiration to physicians and other 30 health professionals in El Paso, throughout Texas, in other parts of the country, and beyond.

Dr. Nickey held many mentoring/teaching positions, including:

- Chief of Pediatrics, Providence Memorial Hospital, 1962-1963, 1978
- Chief of Staff, Providence Memorial Hospital, 1972
- General Chairman, Oral Polio Immunization Program, El Paso, Southern New Mexico, and West Texas, 1963

Dr. Nickey advocated for the development of the US-Mexico Border Health
Commission and was appointed Border Health Commissioner by President Bill
Clinton. Dr. Nickey was critical in organizing support of TMA and county medical

associations along the border, the American Medical Association, and other state medical associations to finally obtain federal approval to establish this binational commission in 1994.
